#### Membership at Gallery X

- \_\_\_\_\_ Family Membership Fee: \$150 (non-active add \$80)

#### ① All Members are entitled to

- Two large group exhibits annually, as well as participation in any exchange or theme exhibits
- Submit proposals for small group or one person shows in either the Main or the Douglass Galleries
- Representation on Gallery X website
- Permanent representation in Gallery Store
- 10% discount on all Gallery X purchases

Payments for artwork will be made to Gallery X and artist will receive payment in the month following the sale. Gallery X will receive 25% commission on works sold.

#### ② Active members are required to:

- Attend monthly meetings, every second Wednesday of the month at 7 pm
- Participate in gallery activities and operations, which also includes gallery sitting once a month In extenuating circumstances, arrangements can be made for an approved proxy sitter.

Members who do not fulfill their participatory obligations for one quarter will be charged the non-active fee.
